WHEREAS, the current Special Counsel for the Village, Feerick Lynch MacCartney, Esqs. ("Special Counsel") is prepared to undertake the defense of the Village in the condemnation cases now pending upon the same terms and conditions as the prior Counsel for the Village as well as undertake the potential recovery of the over \$500,000 expended by the Village in the <u>Little Angels</u> matter upon a twenty-five (25%) percent contingency basis of any such recovery; and
